## 2017 Miss Labor Day Queen Pageant

### September 1, 2017 in Princeton, Indiana

#### Pageant Rules:

1. Each contestant must be the family member of a Labor Day Association member. Contestants must contact their union, and the union must acknowledge sponsorship by signing the entry form and providing the contestant with their local Union shirt. Each contestant must have a sponsoring union.
2. There is a limit of four (4) contestants from each Association Union.
3. Each contestant must be between the ages of 16 and 21 as of the date of the pageant.
4. Contestants must never have been married.
5. All contestants must NOT be holding any current beauty pageant title at the present time. (Title is defined as Queen of any other pageant.)
6. **Entries must be submitted to the Pageant Director by the deadline of Monday, August 7, 2017.**
7. **There is a \$20.00 entry fee, and any check must be made out to the Labor Day Association. It should accompany this application.**
8. A copy of your school and other activity schedule must accompany the application. This is for scheduling the mandatory practices. 2" heels are required at all practices.
9. **Photos for our annual Labor Day brochure will be taken on August 7, 2017 (6:00 pm)** at the USWA Local # 104 Union Hall, 3966 Red Brush Rd, Newburgh, IN 47629, (812) 853-3156. If you cannot attend, you will need to provide your "headshot" photo to the Miss Labor Day Director by August 14, 2017 on a digital disc, thumb drive, or high resolution .jpg image via email.
10. **There will be a short meeting following the photo session on August 7, 2017.**
11. Contestants will be scored on the basis of personality, stage presence, poise, and Union knowledge. Points and score sheets are for the judges' assessments only. Final selection is the judges' decision.
12. Interviews will be closed, as they are for contestants only. (not public)
13. The public portion of the Pageant will consist of 3 outfits, an introductory speech, and 2 on stage questions. Attire includes: Union shirt (from sponsoring local union) with jean shorts and white tennis shoes, Red, White, & Blue wear (to show individual contestant's originality and personality), and evening gown (one piece, floor length).
14. All outfits must be approved by the Miss Labor Day Pageant Director prior to the day of the pageant before they will be allowed on stage.
15. Any rule decisions or clarifications will be the responsibility of the Miss Labor Day Pageant Director. ALL decisions will be Final.
