## Entry Rules for Boonville, Indiana

### Rules:

1. Contestant must be the Daughter, Granddaughter or Nieces (“step” & “great” relationships acceptable) of a Labor Day Association union member. **Entries MUST be received by August 13, 2010, with entry fee**
2. Contestant must be between the ages of 5 and 8 by **August 31, 2010**.
3. Contestant is required to wear casual sportswear; something you would wear to school or church.
4. Contestant must attend one (1) rehearsal; September 1 @ 6:00pm at Warrick County fairgrounds.
5. Contestant will be judged on appearance, personality, and stage presence.
6. Little Miss will ride on The Labor Day Association Float during the parade. All other participants are to be in the parade with their sponsoring union. The Parade starts at 9:00am
7. There is a limit of four (4) entries per local.
